Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	<b>\$2,000</b> person/ <b>\$4,000</b> family. Doesn't apply to preventive care.	Generally you must pay all the costs from providers up to the <b>deductible</b> amount before this <a href="#">plan</a> begins to pay. If you elect individual coverage, you must meet the individual coverage deductible amount. If you have family coverage, family members must meet their own individual minimum annual <b>deductible</b> of \$2,800 as defined by the IRS guidelines until the family deductible has been met.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <b>Preventive care</b> is covered before you meet your <b>deductible</b> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply.
